POLICY ON THE PROCESSING OF PERSONAL DATA

DATA CONTROLLER

SECURITY

The Controller has adopted technical and organisational measures that guarantee a level of security which is adequate to the risk, and conforms to the laws on the processing of personal data.

INFORMATION ON THE TYPES OF DATA PROCESSED

A) REQUEST THROUGH CONTACT FORM

The completion and submission of the contact forms on this website requires the Controller to acquire and process the sender's contact details, which are necessary in order to reply, as well as all the personal data included in the message.

Purpose and legal basis for the data processing (Article 13 paragraph 1 c GDPR)

Contact data is requested. It is used in order to provide a response and/or to contact the data subject.

Scope of communication (Article 13 paragraph 1 e and f GDPR)

The data is only processed by duly authorised, trained personnel.

Your personal data will not be disseminated, nor transferred to countries outside the European Economic Area.

Data Conservation Period (Article 13 paragraph 2 a GDPR)

The data is kept for the time necessary to fulfil the request for information and exclusively the sending of communications which the Controller provides upon express request, and in any case, for a period of no longer than 2 years.

Provision of data (Article 13 paragraph 2 e GDPR)

Failure to provide the requested data means that the message cannot be sent.

B) BROWSING THE WEBSITE

While browsing the website, a series of personal details will be processed, such as IP addresses, domain names of the computers used by the users, webpage of origin and exit, URI/URL addresses of the requested resources, the date and time of the visit, information about the data subject's operating system and browser, and further technical data relating to browsing.

Purpose and legal basis for the data processing (Article 13 paragraph 1 c GDPR)

The processing of this data – in automated, aggregate form – is done solely for purposes relating to the management and administration of the website, and for statistical purposes. **The data may also be used to ascertain liability in the event of computer crimes against the website and/or in the case of other offences.**

The legal basis is the legitimate interest of the Controller.

Scope of communication (Article 13 paragraph 1 e and f GDPR)

The data is only processed by personnel who have been duly authorised and trained on processing, and by the website developer and maintenance provider, who is appointed as the data processor. Your data will not be disseminated, nor **transferred to countries outside of the European Economic Area.**

Data Conservation Period (Article 13 paragraph 2 a GDPR)

Except where necessary for investigations resulting from criminal offences, your data will generally not be kept for more than 90 days.

Provision of data (Article 13 paragraph 2 e GDPR)

The data is not provided by the data subject but is acquired automatically by the website's technological systems.

RIGHTS OF THE DATA SUBJECT

The data subject has the right to request and obtain from the Controller, in the relevant cases:

- - access to the personal data and information (Article 15 GDPR);

- - the rectification or erasure of the data (Articles 16 and 17 GDPR);
- - limitation of processing (Article 18 GDPR).

If the processing is based on consent of the data subject, the data subject may revoke that consent at any time, without affecting the legality of the previous processing.

The data subject may exercise their rights by contacting the Controller at the above addresses.

RIGHT OF COMPLAINT

Data subjects who consider that the processing of their data has breached the GDPR may lodge a complaint with the competent regulatory authority.
